Welcome to the sandbox environment for the redesigned ERCOT Market Information System (MIS). There are no digital certificates or roles needed to access this test site.

The goal is to give ERCOT MIS users the opportunity to explore this new interface in a test environment. The feedback you provide will help us make adjustments to improve the final user experience.

**Ready to get started?**

Feel free to explore on your own. Attempt to perform the tasks you typically perform on MIS.

If you're unsure where to begin, we suggest attempting one or more of these example tasks.

- Find your most frequently used report or extract.
- Find a report in the EML by narrowing down the list of products using filters. Example settings:
  - Audience Filter = LSE
  - Channel = MIS: Certified
  - Posting Type = Report
  - Keyword = "Default"
- Use the filters on the category pages to locate Outage information. Example path:
  - From the left navigation panel, select "Grid"
  - Select the "Generation" category page.
  - From the Sub-Category filter, select "Outages."
- Find Real-Time Market reports.
- Find Settlement reports.

Note: The purpose of the MIS redesign is not to eliminate any data currently offered on MIS or to change any ERCOT applications. Although you may not be able to access the data and/or applications you typically use within this sandbox environment, rest assured that all data and applications currently offered on MIS will be available when the redesigned site goes live.

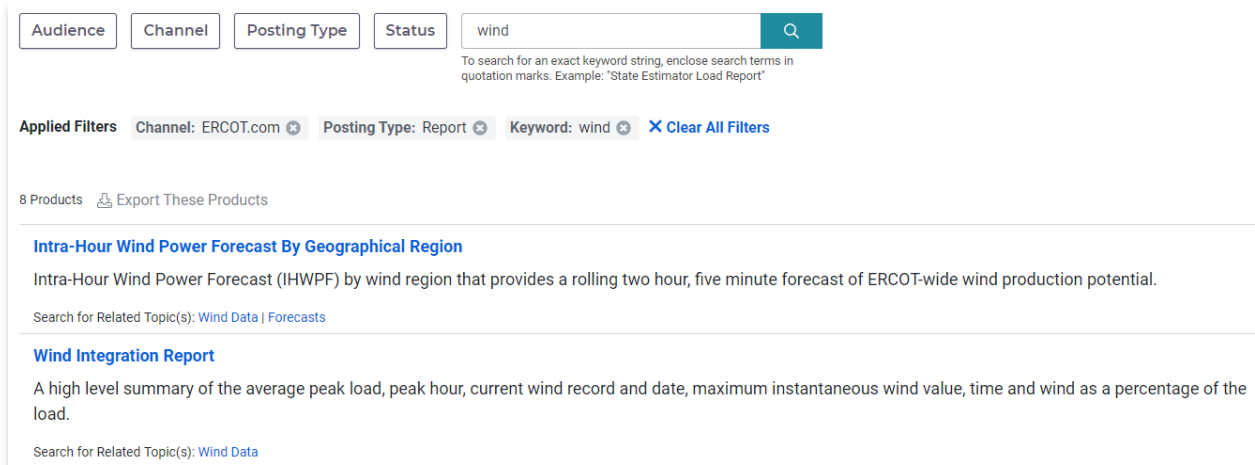

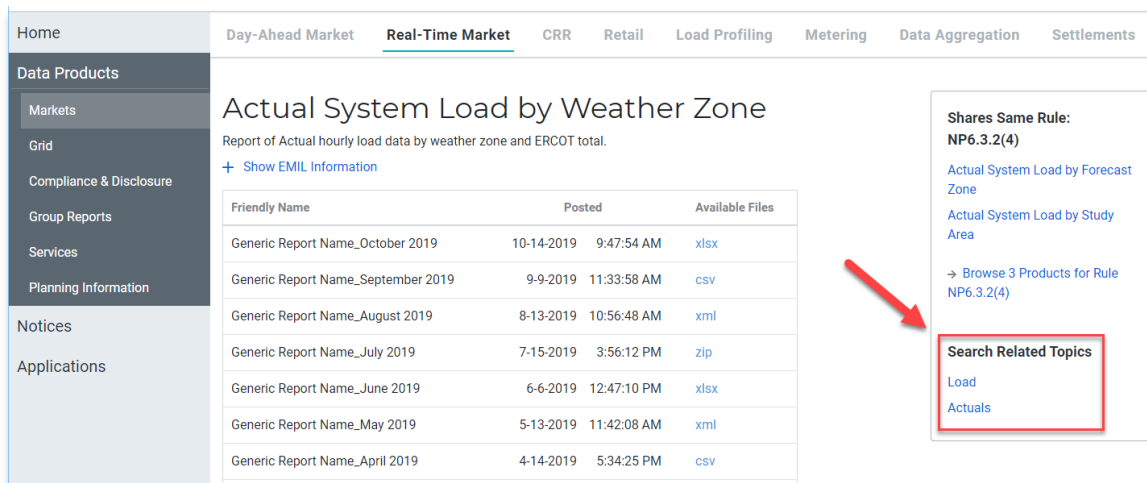
**MIS badge** – Visual cue letting you know when you are authenticated to MIS and are able to see Secure and Certified data (although this functionality is not yet active within the sandbox environment).



**Data product search** – Search for all reports, extracts, notices, and applications ERCOT is required to provide. Narrow a search using filters or keywords.



**Topics** – Tags on data products that, when clicked, allows the user to see similar reports or information.



**Data export** – Export the full EMIL or a subset of products in an Excel file.

## **What isn't available in this sandbox release of MIS?**

The focus of the sandbox release is to get early feedback from stakeholders on the user interface. The Production Preview Release planned for September 2020 will provide an opportunity to test out the fully functional redesigned MIS.

Currently, the MIS sandbox does not contain:

- Digital certificates
- Roles
- Public, secure or certified data
- Ability to display reports based upon role or availability of data
- Notices
- Access to applications (only placeholder links are available at this time)

Note: Some planning studies, such as INRs, are not available in the sandbox release. The team is working on display options. If you are a user of planning information, please email [userexperience@ercot.com](mailto:userexperience@ercot.com) so that your input can be considered.
