ERCOT Market Information System (MIS) Soft Launch Release Notes

Release Date: September 16, 2020

ERCOT is deploying a soft launch version of the Market Information System (MIS) to the production environment on Wednesday, September 16, 2020. It can be accessed at <u>https://mis.ercot.com/public</u>.

The purpose of this release is to allow you the opportunity to identify any issues and validate your information. Please use this soft launch to test any current integrations you may have with MIS.

This is the first release to a production environment. It will run in parallel to the <u>existing MIS site</u>, and it can be accessed using your existing Digital Certificate(s) and role(s).

While the soft launch version of MIS is using production data, there still may be some items that are out of sync with the existing MIS as well as connectivity issues that could disrupt your daily work. The existing MIS site should be used as the official source for production analysis.

Chrome is the preferred browser for this site. If your organization uses Internet Explorer, please see ERCOT's Internet Explorer (IE) 11.x Configuration Guide for compatibility and configuration instructions.







Known Issues Being Addressed

As this is a soft launch of the MIS, there is still work in progress. We are aware of the following issues. If you find additional issues, please report them to <u>webmaster@ercot.com</u>.

- Elements of the MIS home page (https) are pulling from ERCOT.com (http), which is causing the soft launch MIS site to display a warning that the site is not secure.
- The ERCOT Market Information List (EMIL) filtered export does not currently include "Products I Have Access To" and "Products That Have Data" filter selections.
- IE versions 8 and older are not loading site scripts.
- Mobile users may lose the ability to navigate back from lower tiered pages within the site navigation.
