
# Release Date Window: November 17-20, 2021

ERCOT has made enhancements to the ERCOT.com navigation menu as well as some content display changes. In addition, the website will now utilize HTTPS protocol for enhanced security.


## Redesigned navigation structure

The new navigation will span the top of the website only. The left side navigation will no longer be available.

The new navigation is accessible by hovering over the categories at the top of every page:



The current navigation, found on the left side of the screen, will no longer be available:



## **Navigation categories**

The six current site categories (About ERCOT, Services, Committees and Groups, Market Rules, Market Information, and Grid Information) will remain, and an additional category devoted to Market Participants will be added.

The Market Participants section will contain grid and market dashboards, the searchable ERCOT Market Information List (EMIL), the Market Information System (MIS), as well as quick links to market rules, market communications, and the meeting calendar.




The **MIS LOG IN** button above the navigation categories will allow users with Digital Certificates to authenticate to the MIS for viewing Secure and Certified products.

# Added mobile responsive capability

Portions of the website will now be mobile responsive, for easier viewing on mobile phones and tablets.

Due to this enhanced capability, there will no longer be "Mobile Version" links on the Meeting Calendar pages of the website. The Meeting Calendar will be viewable on mobile devices and users will still be able to add meeting events to their personal calendars (by clicking/tapping the + icon next to the event).





## **URL** changes

URLs will change with this website release. Users will need to update bookmarked pages.

- The website will now use HTTPS protocol for enhanced security, thereby changing all current HTTP URLs to HTTPS.
- The URL path for public reports and extracts will change. This is due to a Nodal Protocol Revision Request (NPRR1039), which removed the defined term Market Information System (MIS) Public Area from the Protocols and replaced any references to MIS Public Area with "ERCOT website." An example of a public report URL changing is:

- There is no longer a Public portion of the MIS; therefore, links containing mis.ercot.com/public will now be invalid. To access the information previously located at mis.ercot.com/public, please visit the Market Participants tab at <a href="https://www.ercot.com/mp">https://www.ercot.com/mp</a>. The ERCOT Market Information List (EMIL) contains the Public data ERCOT is required to post. Secure and Certified information remains available at <a href="https://mis.ercot.com/secure">https://mis.ercot.com/secure</a>.
- The URL path for dashboards will change. An example of a dashboard URL changing is:

# **Frequently Asked Questions**

Will my existing Digital Certificate(s) for the ERCOT Market Information System (MIS) still work?

Yes, Digital Certificates will still work. There will be no changes at this time to the Digital Certificates that are used to authenticate with the MIS. Click the **MIS LOG IN** button above the site navigation to authenticate to MIS.



#### Will the URLs to any of the ERCOT applications be changing?

No. The URLs to ERCOT applications will not change with this release.

## Will I still be able to search the ERCOT Market Information List (EMIL)?

Yes. The EMIL will continue to function as it does today. You can find it in the new Market Participants navigation category.

#### What is the preferred browser of the new website?

The new updated website will perform best on Chromium-based browsers such as Chrome and Edge.

## Will the GetReports functionality remain after this release?

Yes. The GetReports (GetReports.do?reportTypeId) functionality for downloading reports will remain available.

#### Will any information be removed from the website?

No. Previous communications indicated that information 7+ years old would be removed, but that is no longer the case. All information that was previously available on ERCOT.com will still be available after the release.

#### Will I still be able to subscribe to RSS feeds?

RSS feeds will no longer be available.

I have multiple Digital Certificates to authenticate with the ERCOT Market Information System (MIS); is there a way to switch between Digital Certificates in one browser session?

This can be achieved using the Microsoft Edge browser. In Edge, click your profile circle (your picture or profile icon) in the top right corner of the browser window. Select **Add Profile**. Follow the steps to create a new profile. Once a new profile is established, open a browser window using different profiles and you will be able to authenticate to access ERCOT Secure and Certified information with a different Digital Certificate in each window.
